## **ADMISSION REQUIREMENTS**

To be considered for admission, an applicant must meet the AUA General Admission Requirements (see the AUA website), as well as Law Department-specific requirements:

- Bachelor's degree in law or related field from a recognized institution of higher education
- Law School Admissions Test (LSAT) at a level acceptable to the Department
- Experience in legal practice or a related field is highly desirable

### **ABOUT AUA**

## LL.M. PROGRAM

The LL.M. is a two-year part-time evening program. Typically classes are held four nights a week after 6 p.m. during the regular academic year. At AUA, students work toward their degree by earning credits. Credits are earned by successfully completing courses. To earn the Master of Laws (LL.M.) degree, students, at a minimum, must earn a total of 32 semester credits: 30 credits from the LL.M. curriculum and 2 credits from the environmental science program. All LL.M. students must complete a set of core law courses, which constitute roughly half the credits required for graduation. To earn the remaining credits students have the opportunity to choose from a variety of "elective courses." By appropriately choosing elective courses, students can tailor their education to focus on either the public or the private law sphere. Before graduating all students must also complete a Master's Paper presenting original research on a topic approved by the Department. This is an opportunity to produce publishable work in English.

## **CURRICULUM**

The LL.M. curriculum is designed to build essential practiceoriented skills for attorneys while simultaneously offering new
perspectives and knowledge on a variety of legal topics. The
curriculum includes a number of core courses which are required
for all students. In addition, the curriculum offers a number of
"elective courses" from which students can choose as they earn
credits toward their degree. By offering choice, students can
tailor their educational experience to their interests and goals.
The curriculum also includes "topics courses" which allows the
LL.M. program to periodically offer students courses on timely
and special topics of interest in law.

#### A PRACTICE-ORIENTED APPROACH

AUA's LL.M. program aims to help students develop the practical skills and knowledge necessary to be an effective professional in an ever more competitive globalized market. Our practice-oriented approach emphasizes analytical, advocacy and English communication skills that attorneys need to succeed. Courses are designed to expose students to a range of fields as well as current trends. The program affords students opportunities to develop practitioner skills through instruction and daily interaction with highly qualified professionals.

The LL.M. is a rigorous academic and professional program. Instructors have high expectations of students. Although many students work, it is often difficult to balance the demands of work, courses and family. The grading scale for coursework is in line with US law school programs. AUA requires students to maintain a minimum grade point average of 3.0 to remain in good standing and graduate.
